Double-sided auctions ensure long-term offtake for suppliers while also subsidising prices for consumers. Revenues generated from carbon pricing can fund auctions and narrow the price gap between fossil and PtX fuels. Rising blending quotas increase willingness to pay on the demand side. As PtX supply grows, prices fall, reducing the subsidies required to finance auctions.
